O.C.C. Transport - September 2016

In September 2015, Oxfordshire County Council implemented a new School Transport Policy. The provision of free transport depends on your address and spaces available at your nearest secondary school.

Prior to the implementation, The Warriner Primary Partnership schools, as well as the Local Authority Admissions section were informed, "Dr Kay and the Governors are determined that no student within our catchment who wishes to come to The Warriner School will be prevented from doing so for financial reasons. We will review each case individually and, where appropriate, provide financial support."

On 1st March 2016, O.C.C. Admissions section sent out offers to Year 6 parents for a place at The Warriner School for September 2016. If you have been informed you are not entitled to free school transport to The Warriner School in September 2016, we recommend you:

- Respond to O.C.C. Admissions Section and accept the offer of a place at The Warriner School by 21st March 2016
- Request an Application for Concessionary Travel 2016-17 Academic Year from O.C.C. available in May 2016

The Governing Body has agreed to provide a Transport Bursary 2016 -17 for parents who have purchased a concessionary fare. In order to assess each individual request and overall demand for transport, we need you to complete the attached School Transport form and return to Leigh Barmby, School Business Manager, The Warriner School, Bloxham, Oxfordshire OX15 4LJ as soon as possible.

Requests will be considered by Dr Kay and The Warriner School Governing Body.
