The relevant member of staff calls for emergency assistance immediately if the pupil's symptoms worsen. Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others. Areas used by unwell pupils who need to go home are thoroughly cleaned once vacated. As a result, any member of the school community who becomes unwell, is isolated quickly and appropriate action is taken to minimise the risk of infection.
