## Enrichment Days 2019-20

I have pleasure in providing the Enrichment Days Programme for Year 8 students this year.

Our Enrichment Days give teachers the chance to organise activities for students that are not normally possible within the restrictions of the school timetable. The cost, detailed on the programme, includes transport, insurance and entry/ticket charges for trips out of school. For all trips students will be required to bring a packed lunch and wear full school uniform, sensible footwear and a waterproof coat. Students in receipt of free school meals can order a packed lunch in advance. Please indicate dietary requirements.

For each set of days students' activities will be determined by their wing:  
Tuesday 1<sup>st</sup> October 2019: East Wing - Harry Potter Studio Tour; West Wing - Shri Swaminarayan Mandir, Neasden.  
Wednesday 2<sup>nd</sup> October 2019: East Wing - Shri Swaminarayan Mandir, Neasden; West Wing - Harry Potter Studio Tour.

Wednesday 10<sup>th</sup> June 2020: East Wing - Black Country Living Museum; West Wing - PE Day, in school.  
Thursday 11<sup>th</sup> June 2020: East Wing - PE Day, in school; West Wing - Black Country Living Museum.

With the exception of the Harry Potter Studio Tour trip, which will return to school at 5.30pm, all trips take place within the school day, therefore students can use their usual method of school transport.

Please complete and return the attached form by **Thursday 12<sup>th</sup> September** to give your consent to your child participating in Enrichment Day activities this year and provide emergency contact and relevant medical information. We also take photographs of activities which may be published on our website and social media. These are always group shots, from a distance/behind where possible and names of students are never published.

Payment of £57.50 is online through ParentPay and there is a payment plan set up to enable you to spread the voluntary contributions across the year. Trips may need to be cancelled should insufficient contributions be received.
